Any Other Business:

The Committee wished to again acknowledge Straide Badminton Club – for their ongoing support and significant financial contribution to the Community Hall over the last number of years. They have used the Hall to build up strong Adult and Childrens Badminton Clubs and have consistently reinvested their funds into the Hall building.

Meeting noted that the Community Hall had an income of €18,918.86 and expenses of €21,864.68, so a shortfall of -€2,945.82 for the year 2022 (copy of the detailed report available to the meeting). Energy costs were highlighted as a significant ongoing concern throughout 2023 to date. Hall rental costs will have to be reviewed in light of this ongoing burden.

Community Website: Focus on advertising the website to the wider community to try and improve interaction and engagement. Ensure all AGM Reports are posted on the website. Highlight and acknowledge local business community (who have been very supportive) on site also.

Hall Internet Access. Look for the most cost effective provider and ascertain if it is within our budget to install same which might help increase hall rentals and use.

While it was agreed by committee members present, the existing SCDG Committee cannot take on every action (in Straide Action Plan and Biodiversity Plan) a suggestion was made that the Committee should facilitate Community meetings to garner interest in the various actions e.g. host a childcare meeting, Mens Shed Meeting etc.

Number of people suggested we should hold the AGM in the month of September in future. August is a busy/holiday period and possibly negatively affects attendance at the AGM.
